## 1. Justification of late delivery

The first workshop on best practices initially planned in June 2020 as a side event of DIGIDECOM could not take place. With the evolution of the COVID-19 situation, following postponement of Digidecom, we rescheduled this workshop several times, first as a physical workshop in Roma, to be hosted by SOGIN, then as a physical workshop in Finland hosted by VTT and finally only an on-line workshop was organised by CEA in month 17, 21-23 October, merging D5.6 (due Month 13) and D5.7 (due Month16).

Delays have been carefully analysed and won't lead to a global project delay, as all the required WP3 outputs will be forwarded to WP4 on time.

## 2. Participants to the workshop

The workshop was initially planned In Finland just after PREDIS first workshop, in order to optimize travel for partners involved in both projects and to organize some joint sessions to coordinate both projects.

Despite COVID, we kept this idea of 2 joint sessions on-line:

- one organized by PREDIS on 21 afternoon with end users where SHARE consortium was invited
- and one organized by SHARE on 22 morning (dedicated to waste management), where participants to the PREDIS workshop were invited, in addition to other coordinators or partners from other projects related to waste management or characterization thematic areas. They could also attend SHARE meeting on 22 afternoon and 23 morning, dedicated to other thematic areas.

Globally, 70 people attended this SHARE workshop.

## 5. Conclusions

### 5.1. From WP3 T3.1 associated to the workshop: Frederica Pancotti [SOGIN]

The workshop fulfilled its main objective of reviewing the literature research on international best practice and advanced technologies in Decommissioning , including associated waste management, legacy waste management and environmental remediation on sites (task 3.1).

The preliminary results on best practices and on-going international initiatives have been presented for each sub-thematic area.

A productive open discussion has been built among the Consortium partners and the other relevant participants in each session and numerous inputs have been collected and registered in order to feed in the Deliverable 3.1 “Report detailing applicable technologies/methodologies”.

The presentation of on-going international initiatives in the field of Waste management was an opportunity to open the Consortium to collaborative activities and for sharing of experiences.

### 5.2. From WP3 leader: Anthony Banford [NNL]

The purpose of the workshop as planned originally was to bring a community of interested parties/stakeholders together to engage in the SHARE project and with the SHARE project team. Whilst originally planned as a face to face meeting earlier in the project, this virtual workshop worked well and achieved this goal. Attendance was good.

The presentations from other related H2020 projects provided great background information, context and knowledge to support the SHARE team working on Work Package 3. The discussions on the individual themes identified useful input from a range of actors that will feed directly into the review of existing techniques and the gap analysis tasks (WP3).

The Learning From Experience (LFE) of running this workshop ‘online’ will also help the team in the design of the next workshop planned for December 2020.

### 5.3. From SHARE Coordinator : Christine Georges [CEA]

The drawback of the COVID situation was that discussion were more complicate than face to face, even if we had lot of inputs from presentations of other EU projects and from participants through the chat. But the good point was that more people were allowed to participate.

The feedback from this workshop will help us organizing next workshop planed one month ahead (1-3 December 2020), where we have to extend to all thematic areas the exercise done during the present workshop and find way to open the door for next gap analysis.

Especially, we have one month to find the ways to get more benefit from a bigger audience, providing more inputs to the project: more investigation on real needs on site and more information on on-going international initiative , on-going developments, coordination with on-going initiatives in other thematic areas, etc.
